I have been directed to inform you that the government has approved the followings for the on line admissions w.e.f the academic session 2017-18 as per the behalfs given below:-

> The on line admissions will start w.e.f 8th June, 2017 (calendar time) and the last date for applying on-line will be 30.06.2017(12:00 p.m. midnight).

- With effect from the academic session 2017-18 the roll numbers of the students getting admission in first year of under graduate and post graduate course will be " Auto generated" by the system and these roll numbers will remain same for a student for the next 3 /2 years as the case may be. Roll numbers of only those candidates will be generated who have successfully deposited the fee.
 - The e-challans (of State Bank Of India- as approved last year for the Govt. coileges) for all the students who are to be promoted to next class can be generated by the college in advance and the validity or these echallans will be from 01.07.2017 to 16.07.2017. No old student has to fill up form on line for 2017-18.(It is " Applicable for Government Colleges" only.
- The applicants will fill up application form on line in the college @Rs. 15 per application and the college Principal is also authorized to approve 5-10 local vendors/ cyber café(s) at the approved rate as per government procedure and the rate shall not exceed by Rs. 50 per application form.

The fee deposit shall be only through e-challan. The student shall have the option to deposit fee at bank counter/on line through-Billdesk (as per last year approved rates)/free through net banking mode of SBI account/ Paytm/Mobiwik/CSC only. However, the colleges may also collect fee at college counters and the same shall be deposited in the account of SBI very next day in the account.

Under the report section the colleges will have the details of the fee & funds deposited by the candidate. A print out of the report can be pasted in the cash book and the college administration is authorized the pasted copy as entry in cash book and there is no need to write cash book so as to avoid duplicity of work. The print out will be the part of

cash book and will be finged by DDO

All the colleges shall ensure that the "Merit list(s)" shall also be uploaded on college web site under CMS besides pasting of merit list(s) on the notice boards and the same shall be available on the web portal of Higher Education Department, Haryana. An SMS will also be sent to all eligible candidates for the same.

It shall be mandatory for all the successful applicants to submit the hard copy of admission form along with all required documents at college counter at the time of admission only (not on an early date). Verification of hard copy submitted by the applicants with all documents of academics, reservation, weightage etc. may also be done on day to day basis for admissions at local levels for admissions by the admission committees locally.

Each college Principal is authorized to rope in 5-10 students for assistance under "Earn While You Learn Scheme" and the payment on per form basis will be made @ Rs. 15/form as per last year norms(For Govt. Colleges only). In case of Govt. aided and SFS colleges the Principal can seek the services of the students and a payment of Rs. 15 can be charged from the applicant separately but, with a receipt of it. - A copy of Cancelled Cheque in favor of the Principal (Name of the 16. college) will be required from all the Principals of Govt. Aided and SFS colleges.
 - No prospectus shall be printed for 1st year students applying in Under graduate and post graduate course(s) of all the Govt. Aided and SFS colleges.
 - Centarlised On line admissions will be mandatory for all courses in all 18. Govt., Govt. aided and Self Financing degree colleges (Budgeted and SFS both at 1st year only, i.e., entry level in budgeted and SFS courses in undergraduate and post graduate programmes both, in all Govt., Govt. aided and SFS colleges).
 - The fee will be charged by the college as being done in the past and will be filled by the college itself.(Applicable in cases of Govt. Aided and SFS colleges).
 - Mode of payment may be -Online/Paytm/Mobiwick/CSC, Inter net Attested to be this copy Debit card/POS machines etc. However, cash

- 23. Hard copy has to be deposited at college counters along with copies of all testimonials and weightage, Aadhar, bank details etc. at the time of admission only.
- Admission schedules and generation of Merit lists (System generated) and schedule of generation will be in accordance with the affiliating university quidelines.
- 25. Cash book and University returns will be system generated.
- 26. Application forms may be filled by the candidates from anywhere/at College/ approved vendors which will be notified by college Principal along with rates after inviting quotations locally.
- 27. After each successful step the student will be notified through SMS.

Since all the affiliating Universities have failed to elaborate the details w.r.t. the "Gap Year, it has been decided by the government that for admission purposes a gap year of UPTO ONLY TWO YEARS will be admissible.

the affiliating universities have not defined the number of subjects to be considered for generation of Merit list i.e., whether 5/6 subjects in the 10+2 examination. It has been decided by the government that best of "TOP FIVE" subjects shall be taken into account for merit purpose in admissions, provided that the student shall have the required compulsory subject in 10+2 for becoming eligible for admission for a particular stream viz. Commerce, Non medical, Medical etc. as per the conditions of the affiliating university. However, in the vocational courses(s)under 10+2 or equivalent ,THE CEILING WILL BE INCREASED TO maximum marks of 600 AS ALL SUBJECTS ARE COMPULSORY SUBJECTS. The decision is taken to maintain uniformity in admissions in all colleges.

The fee and the funds to be charged by the college shall be in accordance with the information sent to the government by the college Principal. Any further deviation of any kind will be NOT BE ACCEPTABLE to the State government and shall also be NOT Applicable in any case for the purpose of admission in any respect and hence, cannot be charged from the student at the time of admission hence forth.

Facility is provided to the college Principal for charging fee on annual/semester/ installment /concession basis, but the concerned Principal has to assign reason in writing in the check box for such concession, if any, at the time of generation of e-challan for admission of a student(s) and the government will not be liable for nonpayment of such balance fee by the student at a later stage to the concerned college administration.
