

Dear Sir,

I am desired to refer to your application No. ASSK/81/1 dated 29.10.82, on the subject cited above and to inform you that on the recommendations of the Report of Inspection Committee, the Vice-Chancellor has been pleased to grant Provisional Recognition/Affiliation on temporary basis, in anticipation of the likely approval of the Executive Council, to the Dayanand Mahila Mahavidyalaya, Kurukshetra to start the Pre-University Arts and B.A. Part-I (English, Hindi, Sanskrit, History, Political Science, Economics, Mathematics, Music (Vocal & instrumental), Psychology, Home Science) and Prep. Commerce and B.Com. Part I (One Unit) classes w.e.f. the academic session 1982-83 in the first instance on the fulfilment of the following conditions:-

1. That the Management of the proposed College shall provide for the College the entire building (Ground Floor) duly furnished with fans, doors/windows, furniture, and Black-boards/taps (whenever necessary) latest by 30th July, 1982.
2. The College Management shall meet the requirements of accommodation on the College premises as under:-
 1. Class-rooms - Six (3 for Pre-University & 3 for B.A./B.Com.)
 2. Teacher's room - One
 3. Common Room - One
 4. Library Room - One (also to be used as Reading-room).
 5. Typewriters Room - One
 6. Sports Room - One
3. Construction of the office of the Principal and other office staff.

The College shall have teaching and non-teaching staff according to the provision as laid down in the University Calender, after adopting the proper procedure, for the purpose in question. The appointments of the required staff should be made by 30th July, 1982.

5. Required number of equipment like Typewriters(1 for each 4 students) and Laboratory for Home Science, games material and Musical Instruments shall be purchased by the College immediately.
6. The College shall purchase furniture equal to the amount of Rs. 50,000/- immediately or more as per requirements.
7. The College shall purchase Library books as per requirements directly related to the Courses in the beginning of the session and other standard books be purchased before March 31,1983.
8. The College shall provide its own hostel facilities to the students.
9. The College shall provide residential accomodation for the principal on/near the College Campus, as soon as possible
10. The College Management shall submit immediately the plan of of the College Building duly certified by a qualified Engineer.

The College shall take immediate necessary steps to fulfill the above conditions and to verify the fulfilment of the same the college shall be re-inspected in the month of October/November,1982



In continuation of this Office Endst.No. CER/ASSK/82/11445, dated 24.12.1982, relating to the subject cited above, I am desired to inform you that the Inspection Report of the inspection conducted on 21.2.1983, in respect of your College for the purpose cited as subject has been considered by the Executive Council of this University in its meeting held on 31.3.1983, and has decided to extend the provisional affiliation for the next session 1983-84 to allow the College to continue the starting of (i) Pre-University Arts & B.A.Part-I and to start B.A.Part-II classes with the introduction of the subjects of English, Hindi, Punjabi, Sanskrit, History, Pol.Science, Economics, Mathematics, Music (Inst.& Vocal), Psychology & also to continue the starting of (ii) Prep.(Commerce), B.Com.Part-I & to start B.Com.Part-II (one Unit each) classes, subject to the fulfilment of the following conditions:-

1. ✓ The College should purchase furniture and Shelves worth Rs. 10,000/- to provide facilities in the College Library, as the present provisions for the same are not adequate.
2. ✓ The College shall purchase Library Books worth Rs. 5,000/- for B.A. Part-II & B.Com.Part-II classes during the session 1983-84. In addition to this the College shall also purchase Library Books worth Rs. 10,000/- as no amount has been spent for the purpose in 1982-83.
3. ✓ The College should purchase equipment worth Rs. 5,000/- for the Home Science Laboratory.
4. ✓ Similarly, the College should spend Rs. 5,000/- for the purchase of equipment for Music.
5. The College should appoint a full fledged Lecturer in Commerce instead of appointing a Part-time Lecturer in Economics & a Part-time Lecturer in Commerce, so that Lecturer so appointed may teach both Commerce & Economics subjects during the session 1983-84.
6. ✓ Some more Typewriters should also be purchased by the College to facilitate the teaching of Typing in Pre-University(Commerce).
7. ✓ The 1st floor of the College building should be completed ~~to~~ very ~~fast~~ soon and it should be furnished with Windows, Doors, Boards, Fans and other amenities, before the starting of the next Session 1983-84.






1. The Vocational courses for which the UGC has agreed to extend support has/have been approved by the concerned academic bodies of the respective University/Autonomous Colleges.
2. The Institution will set up guidance and counselling services to assist students to inform students' educational and vocational choices for establishment of liaison with employing establishment and for understanding follow up studies of students.
3. The approved vocational subject will be introduced as part of the existing B.A./B.Sc./B.Com. courses in combination with 2-3 non-vocational subjects as prescribed under University/College regulations.
4. The Institution will admit 30 students to each approved vocational course as per the norms and criterion prevailing in the Institution.
5. In the context of the local conditions, some changes/modifications in the course content can be carried out. But it should be ensured that such changes should enrich the course content and it should not, in any case, lead to dilution.
6. The Institution will follow the model Academic Calender suggested separately by the UGC.
7. For practical training the students of Vocational streams will be attached with the local institutions and employing establishments which have laboratory/workshop facilities related to the new course and where adequate supervision by qualified personnel will be available. For this purpose the institution will sign a MOU (in the form prescribed by the UGC) with the respective local training institution and employing establishment detailing out the support that the latter can give to the institution for effective implementation of the programme. However, in exceptional cases where it is found difficult to get an establishment sign an elaborate MOU, the industry should be requested to give a written assurance to the institution that they would arrange training for the students and provide other support.



The colleges shall make admissions against these additional seats for the session 2015-16 if application forms for admission to above classes are lying pending, subject to the condition that the admission shall be made against these seats strictly on merit basis and as per instructions/guidelines issue by the University from time to time.
