I am directed to invite your kind attention to this office letter of even no. dated 10th August, 2018, vide it was directed to all concerned for immediate suspension of facilities like Social Pensions, Scholarships and Arm Licences in respect of every person against whom charges are framed by a court for a sexual crime against a woman or a child. Now, in this regard, a new domain i.e, "hrycrime-wc-gov.in" has been designed and developed by NIC, Haryana for feeding of data for those persons.

2. The website is now live and ready for the data feeding from the relevant users **(Police and Prosecution at District level)** which are required to enter the data and other departments concerned will monitor and review the same and further suspend the facilities provided by their respective departments. As a pilot run, this exercise is being started from District - Panchkula and later on will be applied in all districts of the State. **The Credentials for all relevant and defined users as listed above will be shared through email only being confidential in nature.** All the above users are also requested to change their passwords on their first successful login for security reasons.



Subject: - Regarding immediate suspension of facilities like Social pensions, Scholarships and Arm licences in respect of every person against whom charges are framed by a court for a sexual crime against a woman or a child.

Sir/Madam,

I have been directed to address you on the subject cited above and to inform you that Hon'ble Chief Minister, Haryana had announced immediate suspension of facilities like Social pensions, Scholarships and Arm licences in respect of every person against whom charges are framed by a court for a sexual crime against a woman or a child.

2. Further, the Hon'ble Chief Minister has directed that all the steps including sharing password of CCTNS with the Deputy Commissioners shall be taken to ensure that advance action on benefits would need to be suspended in respect of which person(s), is initiated as soon as any FIR is registered under any one or more of such sections viz. Dowry Death 304-B IPC, Rape 376 IPC, Attempt to Rape 376/511 IPC, Sexual Harassment 354-A IPC, Disrobing 354-B IPC, Stalking 354 D IPC, Eve Teasing 509 IPC, Acid attack 326-A/326-B IPC, Trafficking of women 370 IPC, Exploitation of Trafficked Women 370-A IPC or any section of the POCSO Act, 2012.


3. Hence, the following directions are issued with the approval of the Hon'ble Chief Minister:-

- (i) Every Deputy Commissioner shall get prepared a list of all the persons who stand so charge-sheeted already during the current calendar year up to 30th June, 2018 and ensure that all the benefits mentioned above are immediately suspended in respect such persons. A confirmation shall be sent to the ACS (Home) by 31.08.2018.
- (ii) Department of Social Justice & Empowerment will amend their schemes to include conviction under any of these offences as disqualification for old age, handicapped, widow or any other social security pension.
- (iii) Department of School Education, Higher Education, Technical Education and Industrial Training shall do the same in respect of all scholarships.
- (iv) A list of all persons convicted under above mentioned offences since 1st November, 2016 along with their Aadhar Numbers will also be prepared and shared with Departments of Social Justice & Empowerment, School Education, Higher Education, Technical Education and Industrial Training by the Director Prosecution by 31.08.2018.
- (v) Henceforth, a list of all persons so charge-sheeted during the previous week shall be shared by District Attorneys with DCs and

SPs/CPs every Monday who, in turn, shall immediately take action for suspension of arm licences in respect of such persons.

(vii) DCs shall also share these weekly lists with the concerned District Heads of the above mentioned Departments to ensure strict compliance of these orders.




